Introduction

The issue of legitimacy and democratic participation is crucial to understand the evolution and orient the governance of the European Union. The growing complexity of the EU framework, involving new stakeholders and competing interests, calls today for a debate on the resources needed to foster its sustainability.

Being aware that the political popular participation is the main source of power for democratic systems, the Conference aims to confront the crucial issue of political parties role in aggregating the political demand and orienting popular participation. The objectives of AUSE Annual Conference are:

- explore the hypothesis of the development of genuinely transnational European parties system;
- contribute to the renewal of the political culture of parties;
- explore the ways how European political parties can contribute to the development of a truly European demos and electorate, promoting a transnational aggregation of the political demand;
- contribute to citizens' acquirement of knowledge and development of their political culture;
- promote active participation channels, accessible to citizens and civil society actors.

Call for papers

Professors, researchers and PhD Candidates are invited to present contributions <u>according to the four Conference</u> themes/sessions: 1) towards an European transnational party system; 2) towards a more active European citizenship; 3) towards 2014 elections to the European Parliament; 4) dialogue, political parties and civil society organisations in democracy transition in southern Mediterranean.

Multidisciplinary and interdisciplinary contributions are mostly welcome from political science, law, history, economics, sociology, philosophy disciplines. A specific session of the Conference will be dedicated to PhD Candidates.
